ABOUT NEST

Founded in 2006, Nest (www.buildanest.org) is a nonprofit organization that is building a new handworker economy to generate global workforce inclusivity, improve women's wellbeing beyond factories, and preserve cultural traditions of craft. Working hand in hand with brands, philanthropists, and artisan businesses, Nest is using radical transparency, data-driven development, and fair market access to connect craftspeople, brands, and consumers in a circular and human centric value chain.

OVERVIEW OF ETHICAL COMPLIANCE PROGRAM

- Focused on artisan, small workshop, and home-based producers
- Program begins with training first and is designed to work hand-in-hand with your business to establish viable compliance policies and procedures
- Based off of traditional factory compliance models, but translated into a context that makes sense for non-factory production, including subcontracted production
- · Created in collaboration with leading brand partners, compliance experts and artisan business leaders
- SCOPE: production that falls outside of 4-walled factory production
 - > Small workshop definition = 20 or fewer workers, and no more than 10 using power machinery, open flame or chemicals
 - > Home-based workshops
- · Not designed as Pass/Fail, but a consumer-facing Seal is awarded to groups that meet a particular threshold of compliance

Creating an environmental policy for your business to reduce negative impacts

HOW IT WORKS: STRUCTURE OF THE PROGRAM

- 1. Initial Supply Chain Mapping and Self-Assessment
 - a. Detailed mapping of your artisan/home-based supply chain, including the layers of subcontractors and agents
 - b. Unscored self-assessment to identify the areas that we will focus on together
- 2. Compliance Training
 - a. Leveraging existing practices, and creating new ones, to strengthen compliance processes
 - b. Discuss hurdles to meeting compliance and developing customized solutions
- 3. Post-Training Implementation
 - a. Nest delivers recommendations that outline the areas that need attention
 - b. Via remote check-ins, Nest works with you to implement new policies and practices, brainstorming solutions for trouble spots
- 4. Assessment
 - a. At the 6-9 month mark, Nest comes back to perform an on-site assessment
 - b. The assessment has a very different look and feel from an audit and is designed gather information in a sensitive and respectful way
 - c. The process involves the review of records and policies, conversations with your management team, subcontractors and workers, as well as a review of the workshops and homes where production is taking place
- 5. Post-Assessment Remediation Plan
 - a. The assessment results in a corrective action plan, and Nest works with you to develop strategies that will help address any gaps found
 - b. If your business meets a threshold of compliance, your business will be awarded a Seal of Assurance by Nest

RESPONSIBILITIES OF PARTICIPATION


- Transparency regarding the subcontractors and homes with whom you work
